A RESOLUTION AUTHORIZING THE COUNTY JUDGE OF VAN BUREN COUNTY TO PURCHASE A JOHN DEERE 410L BACKHOE LOADER, TO TRADE IN A 2015 CASE 590 SUPER N BACKHOE, AND TO TRANSFER \$45,000.00 FROM 2000-0200-9999, TRANSFERS OUT, TO 2000-0200-4004 MACHINERY AND EQUIPMENT.

WHEREAS: The Van Buren County Road Department owns a 2015 Case 590 Super N Backhoe; and

WHEREAS: The Case Backhoe has been constantly in need of repair; and

WHEREAS: The County Road Department had to rent a backhoe to complete work while the Case was being repaired; and

WHEREAS: John Deere, through Stribling Equipment, LLC, has offered to sell the rental backhoe for the State Procurement price and give the county full credit for all rent paid (\$15,840.00); and

WHEREAS: The price breaks down as follows:

410L Backhoe Loader	\$102,840.00 State-bid pricing
Trade-In of Case 590 Super N	(\$42,000.00)
Rent Applied	(\$15,840.00)
Total	\$45,000.00

THEREFORE, BE IT RESOLVED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS, THAT:



improvements for the Shady Grove sub-station; and


**WHEREAS:** The County of Van Buren requires assistance to identify and implement the regulations  
pertaining to the said grant; and


**WHEREAS:** it will be necessary for the County Judge to act in connection with the Administrative  
Agreement.


**THEREFORE, BE IT RESOLVED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS, THAT:**

A RESOLUTION AUTHORIZING THE COUNTY JUDGE OF VAN BUREN COUNTY TO APPLY FOR A GRANT ON BEHALF OF THE DENNARD VOLUNTEER FIRE DEPARTMENT.

WHEREAS: The Quorum Court of Van Buren County has determined that the Dennard VFD meets eligibility requirements necessary to apply for a grant under the Rural Services Block Grant Program (RSBGP); and

WHEREAS: The Quorum Court of Van Buren County is a local unit of general purpose government that will provide opportunity for input by residents in determining and prioritizing community development needs; and

WHEREAS: The Quorum Court of Van Buren County recognizes the need for the project, concurs in its importance, and supports the Dennard VFD in its efforts to proceed with the same; and

WHEREAS: The Dennard VFD has provided proof of ownership of the property to be enhanced by the project; and

WHEREAS: the Dennard VFD has provided proof of the property value in the amount of \$7,500.00 to be used as match; and

WHEREAS: The Quorum Court of Van Buren County will appropriate the sum of \$7,500.00 received from the Rural Services Block Grant Program for the project entitled: Purchase of Fire Equipment, if the project is awarded.

THEREFORE, BE IT RESOLVED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS, THAT:

The Quorum Court of Van Buren County affirms its commitment to take all action within its power to facilitate the receipt of the assistance of the community development funds if the Dennard VFD project is awarded a Rural Services Block Grant, and upon receipt to administer said grant by the rules and regulations established by the United States of America, the State of Arkansas and all empowered agencies thereof.
