WHEREAS: These funds are to be readily accessible for use by the Transfer Station at the Van Buren County Solid Waste Management should the need arise; and


WHEREAS: The term for this line of credit will be reoccurring thru the year 2025 and will be in effect with the signing of the letter of credit.





WHEREAS: Employees of the Van Buren County Road Department, as of January 17, 2021, have achieved three (3) years of accident-free service; and


WHEREAS: Safety in the work place saves the county money; and


WHEREAS: The funding for the bonuses has already been approved within the annual budget for 2021 including APERS, unemployment, and all other associated expenses.


THEREFORE, BE IT RESOLVED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS, THAT:
