Work has been completed on Archey Road and the project crew is heading to Rex Road in Alread, then to Crowell Mountain Road.

The weather has been excessively challenging. The Road Crew is working comp time to try to take advantage of the good weather while it lasts. We are grading and mowing nonstop.

We have managed the budget very well considering the loss of severance tax funding.

We were approved for the Arkansas Unpaved Roads Grant on Silver Rock Road for \$75,000.00. The funding is divided in half with the first part before construction begins and the last half issued upon completion.

We submitted a federal grant request on Half Moon Road for 2 miles of pavement. I am optimistic that we will be approved for that grant.
