August 18 through August 20, 2021, which is during the normal third Thursday meeting time; and


WHEREAS: County Elected Officials are encouraged to attend the conference.

THEREFORE, BE IT RESOLVED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS, THAT:


The meeting of the August Quorum Court will be moved from August 19, 2021 to August 26, 2021 at the



A RESOLUTION AUTHORIZING THE COUNTY JUDGE AND THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS TO ENTER INTO A CONTRACT WITH NORTH AMERICA FIRE EQUIPMENT COMPANY, INC. OF DECATUR, ALABAMA FOR THE PURCHASE OF FIRE EQUIPMENT FOR THE DENNARD FIRE DEPARTMENT.

WHEREAS: Van Buren County, Arkansas has received funding through the Arkansas Economic Development Commission for the purchase of fire equipment; and


WHEREAS: bids have been received for the fire equipment. All bids have been reviewed and a recommendation for award has been made; and

Said cost not to be exceeded without properly executed change orders. The cost of the fire equipment will be paid with grant funds from the Arkansas Economic Development Commission.
