JOURNAL OF PROCEEDINGS
August 15, 2019

The Van Buren County Court met Thursday, August 15th, 2019 at the Van Buren County Courthouse Annex in Clinton, Arkansas for the regular monthly meeting, with Judge James presiding. Members of the Quorum Court attending were Justice of the Peace N. Brown, Linn, Holt, S. Brown, Bradford, Tatum, Lemings, Bass, and Philips. Also attending were Pam Bradford, County Clerk, and Attorney Jacob Franklin, setting in for Carol Crews.

Next: PRAYER: Given by J.P. Holt.

Next: PLEDGE OF ALLEGIANCE: Was recited by all

Next: ROLL CALL: All were present.

Next: MINUTES: J.P. Holt motioned to accept the minutes of July 18th, 2019 as printed. J.P. Lemings seconded the motion. Judge James asked for discussion, there was none. The minutes were approved unanimously.

Next: TREASURER'S REPORT: J.P. Tatum made a motion to accept the Treasurer's report as printed, J.P. Linn seconded the motion. Judge James asked for any discussion. There was none. The Treasurer's report was approved unanimously.

Next: APPROPRIATION ANALYSIS: J.P. Philips made a motion to accept the Appropriation Analysis as printed, J.P. Holt seconded the motion. Judge James asked for any discussion. There was none. The Appropriation Analysis was approved unanimously.

Next: COUNTY ROAD AND EQUIPMENT REPORT: Judge James gave the County Road Report. [Report Attached]

Next: SHERIFF'S REPORT: Sheriff Emberton gave the sheriff's and animal control report. [Report Attached]

Next: Eric Ekhoft with Van Buren County 911 talked about survival flight. He stated those who need care will be sent to the closest hospital that will give the best care if the local hospital does not have a way to care for the patient.

Next: Levi Finch with Telogix phone services gave an assessment of what the company could provide for the county offices.

Next: Danny Griffin thanked the quorum court for their support of their agricultural programs. Torrie Smith gave an assessment of these programs.

Next: Johnny Rhoda, chairman for the VBC Election Commission, stated the voting equipment needed to be updated and the state wanted it to go before quorum court. He also advised that the Election Commission had voted to go to Voting Centers by the 2020 election. Voters will be able to vote at any of the polling sites and it would save the County money.

- A. NEXT J.P. BRADFORD READ AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE #2019-59, THE ANNUAL OPERATING BUDGET FOR 2019, TO INCREASE THE PROJECTED REVENUE AND APPROPRIATE \$43,060.00 INTO THE COUNTY GENERAL FUND #1000-100 COUNTY JUDGE BUDGET, FROM THE COUNTY ROAD FUND #2000-200.** After reading the ordinance, J.P. Bradford made a motion to adopt, seconded by J.P. Linn. Judge James asked for any discussion. J.P. N. Brown asked if it should be written county Judge's budget instead of county road in the 'where as' clause of the ordinance. The ordinance was approved and given **No. 2019-35.**
- 1. NEXT J.P. TATUM READ A RESOLUTION AUTHORIZING THE COUNTY JUDGE OF VAN BUREN COUNTY TO PURCHASE A USED DYNAPAC CA1400D SOIL ROLLER.** After reading the resolution, J.P. Tatum made a motion to adopt, seconded by J.P. Philips. Judge James asked for any discussion. J.P. Tatum asked the judge to explain the kind of roller. The resolution was approved and given **No. 2019-11.**
- 2. NEXT J.P. S. BROWN READ A RESOLUTION AUTHORIZING ARTHUR SCHMECKENBECHER TO PERFORM A WEDDING CEREMONY IN VAN BUREN COUNTY.** After reading the resolution, J.P. S. Brown made a motion to adopt, seconded by J.P. Holt. Judge James asked for any discussion. Judge James stated this has never been done and has checked the legality of the situation. He stated under the statute it states anyone authorized by the quorum court may solemnize a marriage. J.P. Philips asked what approving this resolution would open the door to. The resolution was approved and given **No. 2019-12.**

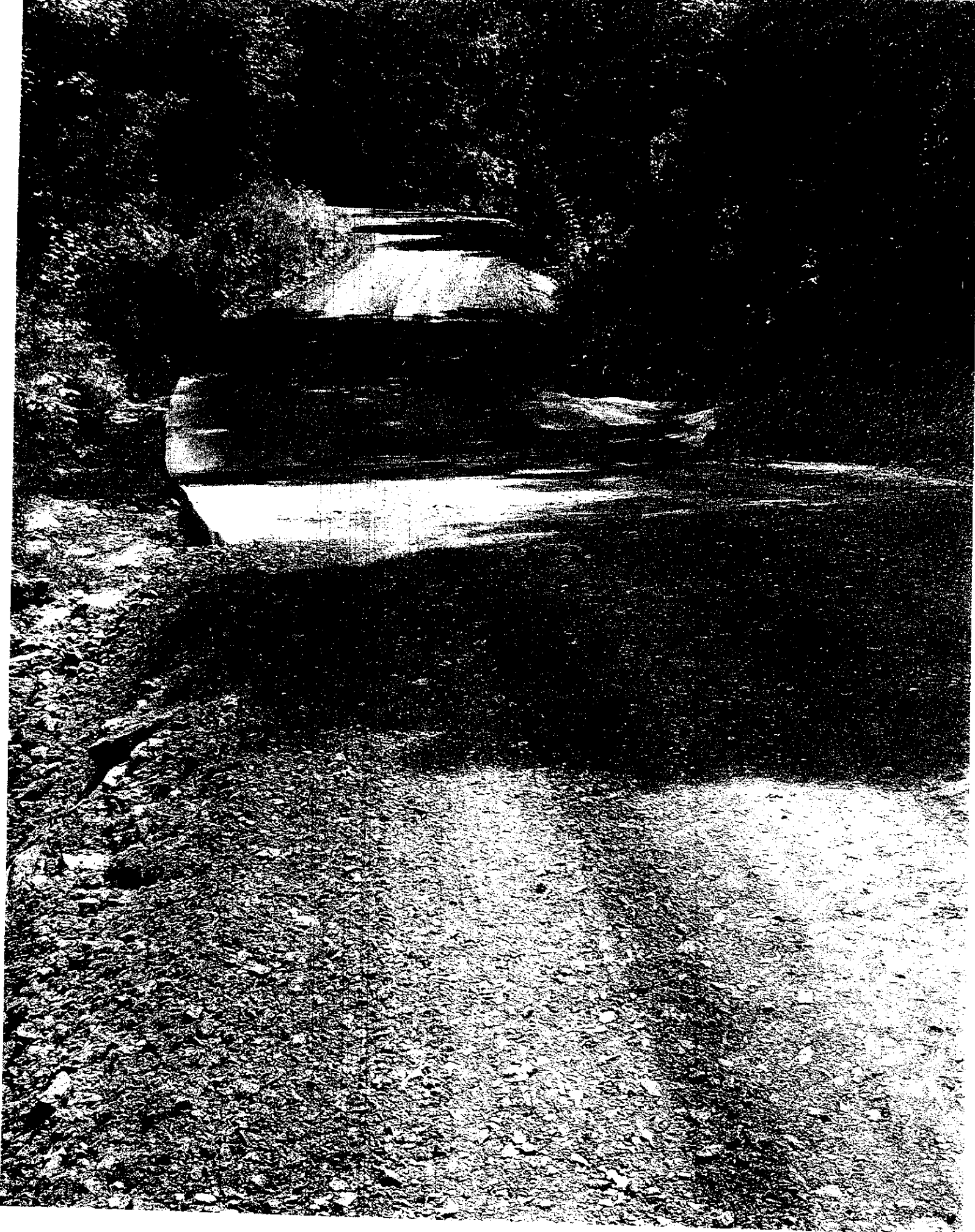
