Fund that should have been paid from the General Budget of the Circuit Clerk.


WHEREAS: the money will need to be transferred and appropriated back into the Recorder's



BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN,
STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE TO ESTABLISH A SPECIAL REVENUE FUND TO BE
NAMED THE COUNTY LIBRARY ARP FUND; AND TO DECLARE AN
EMERGENCY.

WHEREAS: Article 1. Affirmation. It comes before this court that there is a need to establish a special revenue fund on the books of the County to track the revenues and expenditures of federal assistance through the American Rescue Plan Act for the county library. This Court recognizes and affirms the need for such a fund to properly account for and control all such revenues received and expenditures made in compliance with all applicable laws and guidance from the U.S. Treasury.

WHEREAS: Article 2. Establishment of Fund. There is hereby created on the books of the Van Buren County Treasurer and the books of the Van Buren County Clerk a special revenue fund to be known as the County Library ARP Fund with a fund number of 3047 as assigned by Arkansas Legislative Audit. The Revenue Code for the federal assistance through the ARP Act, as assigned by Legislative Audit, is 7112 – Federal Coronavirus Relief.

WHEREAS: Article 3. Operation of the Fund. The County Library ARP Fund is subject to the County budgeting, appropriation and expenditure regulations of Arkansas Code Annotated, Title 14; the claims process for county libraries pursuant to § 13-2-404(c)(1)(2); and the County Financial Management System implemented in accordance with § 14-21-101. Funds must be used only in accordance with guidelines issued by the U.S. Treasury concerning the legal expenditures of revenues received pursuant to the American Rescue Plan Act of 2021 (P.L.11-2), which established the Federal Coronavirus State and Local Fiscal Recovery Fund. Proper records and documentation must be maintained for federal audit purposes.


WHEREAS: Article 4. Emergency Clause. It is found by this Court that the deposit of federal assistance funds from the American Rescue Plan Act are imminent making it necessary to establish the County Library ARP Fund in order to be able to properly track the revenue and expenditures. Therefore, an emergency is declared to exist and this Ordinance shall have full force and effect from the date of passage and approval.

BUREN COUNTY, ARKANSAS THAT:


