WHEREAS: The budget already contains the funds necessary to make the purchase described herein.

The County Judge is hereby authorized to sign for a line of credit in the amount of \$400,000.00 to be used as follows:

3. Each loan may be issued for up to 60 months
4. The number of tractors and/or mowers may vary by each loan
5. Standard interest rates will apply
