WHEREAS: Federal Procurement Policies will be followed for the purchasing; and


WHEREAS: There is a need to approve this project.



THEREFORE, BE IT RESOLVED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS, THAT:


Section 1: Van Buren County, Arkansas pledges its full support to the elimination of litter and littering within the County and State; and

WHEREAS: Federal Procurement Policies will be followed for this project; and





