AN EMERGENCY ORDINANCE TO APPROPRIATE \$225,000.00 INTO THE RESERVE FUND #1001 AND TRANSFER AND APPROPRIATE IT INTO COUNTY GENERAL #1000, TO APPROVE OF A PROPERTY PURCHASE FOR THE DEPUTY PROSECUTOR, TO DECLARE AN EMERGENCY, AND FOR OTHER PURPOSES.

WHEREAS: The Quorum Court previously agreed to renovate space for the Deputy Prosecutor's Office with Resolution # R-2022-28 for the amount of \$150,000.00; and

WHEREAS: It was determined with an architect that the renovations would greatly exceed the anticipated cost of \$150,000.00; and

WHEREAS: The Budget Committee agreed that it is for the best interest of the county to purchase a turn-key ready space without the need to renovate; and

WHEREAS: The space available will cost approximately \$200,000.00 plus applicable closing costs and fees; and

WHEREAS: There is a need to act expeditiously while the property is available; and

WHEREAS: There is a need to appropriate the funds for the transaction as well as to approve the purchase.

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS THAT:

Section 1. The purchase of the following property which is owned by CHAD BROWN and NICKIE BROWN, husband and wife, is hereby approved:

PART OF LOT (9), BLOCK THREE (3), CITY OF CLINTON, ARKANSAS, ACCORDING TO THE WORKMAN PLAT AS REFLECTED IN DEED RECORD BOOK 61 AT PAGES 340 AND 341, DESCRIBED AS BEGINNING AT A POINT51.5 FEET NORTH OF THE SE CORNER OF SAID LOT NINE OF BLOCK 3, RUN THENCE NORTH 23.5 FEET THENCE WEST 145 FEET OR TO BOYKIN STREET, THENCE SOUTH 23.5 FEET AND THENCE EAST 145 FEET TO THE POINT OF BEGINNING.

Section 2. The Quorum Court recognizes that in order for the transaction to happen, that the Browns must act quickly to purchase additional property while it is available, and that this approval must come in a timely manner absent of competitive bidding of properties.

Section 4. \$225,000.00 is hereby appropriated into the Reserve Fund #1001.

Section 5. \$225,000.00 is hereby appropriated into County General Fund #1000-0100-9999 TRANSFERS OUT to cover the purchase price and any other associated costs such as closing costs and fees.

Section 6. Emergency: This ordinance, being necessary for the protection and preservation of public health and safety as well as the continuity of County Government, an emergency is hereby declared to exist and this ordinance shall be in force and shall take effect upon passage and publication.
