BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, A RESOLUTION TO BE ENTITLED:

A RESOLUTION TO ACKNOWLEDGE THE EMPLOYEES OF 911 AS COUNTY EMPLOYEES AND TO CONVEY THEIR ACCUMULATED TIME AND BENEFITS.

WHEREAS: Van Buren County 911 employees have, in the past, been contracted through the city of Fairfield Bay; and

WHEREAS: The decision has been made to make the employees of 911 county employees; and

WHEREAS: There is a need to convey their accumulated time and benefits.

NOW THEREFORE BE IT RESOLVED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS THAT:

- Employees of 911 shall become employees of Van Buren County at midnight, January 1, 2023.
- 2. Employee's compensatory time shall convey to the county as is from Fairfield Bay.
- 3. Employee's years of service shall convey to the county from Fairfield Bay for all purposes, such as for vacation time accrual.
- 4. Employee's accumulated sick time shall convey to the county from Fairfield Bay.
- 5. All time earned and banked while the employees worked at Fairfield Bay shall convey to the county.
- 6. The employee's years of service for APERS purposes shall begin January 1, 2023.

7. Every effort shall be made to provide a seamless transition from Fairfield Bay to the county.
