**WHEREAS:** Resolution R-2022-15 allocated \$20,000.00 for a storm shelter at the Road Department; and

**WHEREAS:** Resolution R-2022-17 allocated \$6,000.00 for a storm shelter at the Solid Waste Department; and

**WHEREAS:** There is a need to increase the budget for the 911 Back-up Facility due to a necessary repair of roof leaks and other purposes.

NOW, THEREFORE, BE IT RESOLVED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS, THAT:


1. Resolution R-2022-15 is hereby repealed; and

**WHEREAS:** Resolution R-2022-31 tied the budget amount of \$45,000.00 to improvements specific to the building; and


**WHEREAS:** The building improvements were completed under budget; and



**WHEREAS:** There is a need to broaden the purpose from the previous Resolution to include office supplies, office furniture, and other purposes.
