The sum of \$48,000.00 be appropriated into the Solid Waste Budget Fund 3009-700 as follows;



SECTION 1. That the various millage enumerated above are as declared and they are hereby approved and levied by the Quorum Court of Van Buren County.



BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, AN APPROPRIATION ORDINANCE TO BE ENTITLED:

AN EMERGENCY ORDINANCE APPROVING A CLASSIFIATION OFFICE #400 FOR FUND #1007, THE LOCAL ASSISTANCE & TRIBAL CONSISTENCY FUND AND TO TRANSFER \$50,000.00 WITH IN THE FUND TO PURCHASE DASH CAMERAS FOR PATROL VEHICLES.

WHEREAS: there is a need to purchase dash cameras for the Sheriff's Office patrol vehicles; and

WHEREAS: the Sheriff's office has secured a grant in the amount of \$50,000.00 toward the purchase of the dash cameras, however the total cost is estimated to be approximately \$150,000.00; and

WHEREAS: the requirement for dash cameras will be mandated in 2025; and

WHEREAS: there are funds available in Fund #1007, Local Assistance & Tribal Consistency Fund.


NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS THAT:

Section 1. \$50,000.00 be transferred into 1007-400-4009, Equipment from #1007-103-9999, to be used toward the purchase of dash cameras.


