ORDINANCE NO. O-2024- 13

BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, AN APPROPRIATION ORDINANCE TO BE ENTITLED:

AN APPROPRIATION ORDINANCE AUTHORIZING THE COUNTY JUDGE OF VAN BUREN COUNTY TO ENTER INTO A LOAN AGREEMENT WITH FIRST SERVICE BANK OF CLINTON FOR A LINE OF CREDIT FOR THE COUNTY ROAD DEPARTMENT AND TO APPROPRIATE THOSE FUNDS INTO 2000-0200-9999, TRANSFERS OUT.

WHEREAS: There is a need for a line of credit to be established at First Service Bank of Clinton, Arkansas; and

WHEREAS: These funds are to be readily accessible for use by the County Judge for the specific purpose of completing mitigation work on Baker Lake Road; and

WHEREAS: The County has already been approved for a reimbursement grant of \$300,000.00 which will fund the payoff for the line of credit.


The County Judge is hereby authorized to sign for a line of credit in the amount of \$300,000.00 to be used as follows:

1. The County Judge has the authority to make the purchase(s).
2. The authority is hereby granted to the County Judge to create an installment loan with First Service Bank.
3. Standard interest rates will apply.
4. The line of credit shall be paid in full and closed upon receipt of grant funds.

And that the amount of three-hundred thousand dollars (\$300,000.00) be appropriated into line item 2000-0200-9999, Transfers Out.

BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE TO CREATE A PART-TIME POSITION AT VAN BUREN COUNTY SOLID WASTE/RECYCLING AND TO TRANSFER MONIES WITHIN THE SOLID WASTE MANAGEMENT BUDGET #3009-0700 TO COVER THE SALARY AND RELATED COSTS.

WHEREAS: Volume at the Van Buren County Solid Waste and Recycling Center continue to increase; and

WHEREAS: There is a need to add additional hours to the recycling side of the operation to keep up with the demand; and

WHEREAS: The monies needed for an additional part-time employee are already available within the budget for Solid Waste.

THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS, THAT:

SECTION 1. A Part-Time recycling position is now created for the remainder of 2024 (\$15.00/hour @20 hours/week with 18 pay periods remaining in 2024).

SECTION 2. Monies for the position shall be transferred from line #3009-0700-9999 Transfer Out, to the following line items:
