BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, AN EMERGENCY ORDINANCE TO BE ENTITLED:

AN EMERGENCY ORDINANCE TO AMEND THE VAN BUREN COUNTY PERSONNEL POLICY.

WHEREAS: All county employees are bound by the terms and policies in the county handbook; and

WHEREAS: The Personnel Committee has met several times and voted to make certain changes to better serve the county.

WHEREAS: Under #6, "Administrative Leave and Other Benefits," section A, "Group Insurance Programs," (a), the following sentence is to be added:

The amount is to be pro-rated for time worked when an employee ends county employment.

WHEREAS: Under #6, "Administrative Leave and Other Benefits," section B, "Holiday Leave," the following paragraph is to be added:

Employees in the Sheriff's Department and the Detention Center will receive their Holiday pay in one lump sum in their first December paycheck, or upon separation from the county for holidays worked at a pro-rated rate, beginning in 2024.

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS THAT:

SECTION 1: The Quorum Court finds that the immediate implementation of this ordinance is necessary to address the needs and concerns of its employees governed by the policy.

SECTION 2: This ordinance being necessary for the preservation of the public peace, health, safety, and welfare, it is therefore declared that an emergency exists, and this ordinance shall be in full force and in effect from and after its passage.
