AN ORDINANCE TO REPEAL RESOLUTION NO. 2019-13 WHICH ESTABLISHED THE VAN BUREN COUNTY UNCOMMON COMMUNITIES COMMITTEE.

**WHEREAS:** Van Buren County, the City of Clinton, and the City of Fairfield Bay agreed to enter into an agreement in which the billboard located at the junction of Hwy. 65 South and Hwy. 330 was to be periodically skinned and the costs associated with the billboard would be shared with said parties; and

WHEREAS: Van Buren County has paid the costs of land lease and replacement skins since 2019; and

**WHEREAS:** The County Budget Committee agreed to defund the Economic Development budget which paid for the billboard maintenance.
