ORDINANCE NO. O-2025- 01

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, AN EMERGENCY ORDINANCE TO BE ENTITLED:

AN ORGANIZATIONAL ORDINANCE REQUIRED BY ARKANSAS CODE ANNOTATED 14-14-904.

WHEREAS: A.C.A. 14-14-904 requires that Justices of the Peace shall assemble on the first regular meeting date after the beginning of the Justice's term to determine the time and place of the Quorum Court Assembly.

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS THAT:

The Quorum Court of Van Buren County shall assemble at 6:00pm on the third Thursday of each month in the Quorum Court Room at the Van Buren County Annex which is located at 1414 Highway 65 South, Clinton.

Emergency Clause It is imperative for county operations to continue smoothly, efficiently and effectively, therefore this ordinance being necessary for the protection and preservation of public health and safety, an emergency is hereby declared to exist and this ordinance shall be in force and shall take effect upon passage and publication.






WHEREAS: Actual revenues have been above projections; and

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS THAT:


The sum of \$28,000.00 be appropriated into the Solid Waste Budget Fund 3009-700-9999 Transfer Out.

AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE #O-2024-54, THE ANNUAL OPERATING BUDGET FOR 2025, TO APPROPRIATE \$10,767.76 INTO THE SHERIFF'S DEPARTMENT BUDGET #1000-400.

WHEREAS: Van Buren County received an insurance Total Loss Payment for a 2020 Dodge Ram 1500 from the Association of Arkansas Counties in 2024, and

WHEREAS: Ordinance #O-2024-48 appropriated this money into the Sheriff's budget in November of 2024; and

WHEREAS: \$9,000.00 of this appropriation was used to purchase a vehicle from the City of Damascus in 2024; and


WHEREAS: The remaining \$10,767.76 will need to be appropriated into the Sheriff's 2025 budget to help in purchasing an additional vehicle.


NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS THAT:

**BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, AN
ORDINANCE TO BE ENTITLED:**

**AN ORDINANCE TO REPEAL RESOLUTION NO. 2019-13 WHICH ESTABLISHED THE VAN BUREN
COUNTY UNCOMMON COMMUNITIES COMMITTEE.**

WHEREAS: Van Buren County, the City of Clinton, and the City of Fairfield Bay agreed to enter into an agreement in which the billboard located at the junction of Hwy. 65 South and Hwy. 330 was to be periodically skinned and the costs associated with the billboard would be shared with said parties; and

WHEREAS: Van Buren County has paid the costs of land lease and replacement skins since 2019; and


WHEREAS: The city of Clinton would like to assume the billboard and all costs associated with the billboard; and


WHEREAS: The County Budget Committee agreed to defund the Economic Development budget which paid for the billboard maintenance.

THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS, THAT:


1. Resolution Number 2019-13 is hereby repealed.
2. The Van Buren County Quorum Court agrees to allow the City of Clinton to take over possession of the billboard and all costs associated with it.
