The amount of \$56,861.01 be appropriated into the Corp of Engineers 2025 Budget #1000-410-9999.




Section 2. Three (3) positions at \$20,280.00 each shall become one part-time allocation of \$60,840.00.



BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, AN EMERGENCY ORDINANCE TO BE ENTITLED:

AN EMERGENCY ORDINANCE TO INCREASE REVENUES AND APPROPRIATE \$54,498.91 INTO THE MAINTENANCE FUND 1000-0123-4002 BUILDINGS TO REPAIR THE ROOF OF THE NORTH ANNEX.

WHEREAS: The roof of the North Annex has sprung several large leaks; and

WHEREAS: There is an urgent and necessary need to replace the roof to mitigate the threat of mold.

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS THAT:

1. The amount of \$54,498.91 shall be appropriated into the Maintenance Fund 1000-0123-4002, Buildings, to cover the price of roof repair of \$49,999.00 plus 9% sales tax.
2. The Quorum Court acknowledges the severity of the situation and agrees that there is not sufficient time to gather sealed bids and approves Covington Roofing to complete the project.
3. The Quorum Court also acknowledges that informal quotes were previously submitted to the budget committee and that Covington Roofing was the lowest of the informal quotes at that time.

EMERGENCY CLAUSE: It is imperative for county operations to continue smoothly, efficiently, and effectively, therefore, this Ordinance, being necessary for the protection and preservation of public health and safety, an emergency is hereby declared to exist and this Ordinance shall be in force and shall take effect upon passage.



WHEREAS: The part-time position created with O-2024-14 was inadvertently omitted.



