WHEREAS: these monies were appropriated in the 2024 Budget by Ordinance #O-2024-50, but were not spent; and


WHEREAS: these grant funds need to be appropriated into the 2025 Budget.

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS THAT:


Section 1: \$7,190.97 be appropriated into #1000-804-3111 for the Scotland Community Grant.

AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE #2024-54, THE ANNUAL OPERATING BUDGET FOR 2025, TO INCREASE THE PROJECTED REVENUE AND APPROPRIATE \$5,803.00 INTO THE FOLLOWING FUNDS/DEPARTMENTS AND TO TRANSFER SAID AMOUNTS INTO #1000-100-3001 ACCOUNTING/AUDITING.

WHEREAS: An extra amount of \$5,803.00 has been charged to Van Buren County from AAC Workman's Compensation for the year 2024 due to extra salaries paid, such as Comp. hours, vacation hours, etc.; and

WHEREAS: this amount has been paid from the County Judge's budget #1000-100-3001 and will need to be refunded from each fund/department it was spent; and

WHEREAS: \$663.00 be appropriated into #1000-400-1010 Workman's Comp., \$21.00 be appropriated into 1000-418-1010, \$4,816.00 into #2000-200-1010, \$16.00 into #3009-700-1010, and \$287.00 into #3020-501-1010 totaling \$5,803.00: and

WHEREAS: these amounts will need to be transferred from each Fund/Department into #1000-100-3001.

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS THAT:

WHEREAS: Van Buren County received a refund of \$6,133.41 from Blue Cross for 2024 after changing health care insurance companies in 2025.; and


WHEREAS: the total of this refund has been placed in County General. Certain amounts will need to be transferred into the appropriate funds.



NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS THAT:




