



WHEREAS: The Annual Audit was completely "clean" with zero findings; and



THEREFORE, BE IT RESOLVED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS, THAT:


1. The 2023 Annual Legislative Audit is hereby acknowledged, accepted, and approved as presented.


