WHEREAS: The County wishes to apply for FUN Park grant funds through the Arkansas Department of Parks, Heritage, and Tourism to improve a public park at the following location:

Alread Park, 20308 Highway 16 West; and

WHEREAS: The County Judge and Quorum Court understand that, if granted funds for park development, they must provide land, by lease or ownership, on which to develop park facilities; and

WHEREAS: Van Buren County, Arkansas, will sign a contract agreeing to provide the necessary resources to maintain the park and facilities for a period of 25 years.
