AN ORDINANCE TO TRANSFER MONIES WITHIN THE ARKANSAS DEPARTMENT OF EMERGENCY MANAGEMENT (OEM) BUDGET FOR PERSONAL SERVICES #1000-500 TO CLEAN-UP PAYMENTS OF COMP. TIME FOR THE OEM AND TO MOVE MONEYS FROM THE COUNTY ROAD BUDGET #2000-200 AND APPROPRIATE IN THE OEM BUDGET #1000-500 TO CORRECT PAYMENTS FOR THE OEM'S DENTAL AND LIFE INSURANCE FOR THE MONTHS OF JULY AND AUGUST OF 2025.

WHEREAS: the OEM was approved by the County Judge to be paid for comp. time in February of 2025. This has resulted in Personal Services being in the 'red' at the end of June 2025; and

WHEREAS: \$380.59 will need to be transferred from line #1000-500-9999 Transfer Out to correct the overage, and

WHEREAS: the OEM position is paid from County General half of the year (Jan.-June) and County Road the remaining half (July-Dec.). Dental insurance for the OEM was paid from County General for July and August and Life insurance for July, and

WHEREAS: the monies will need to be transferred from County Road #2000-200 and appropriated into the OEM County General Budget #1000-500 to correct these insurance payments.

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS THAT:

Section 1. \$329.47 be transferred from #1000-500-9999 Transfer Out to #1000-500-1001 Salaries: Full-Time, \$9.51 to #1000-500-1006 Social Security and \$41.61 to #1000-500-1008 Retirement, totaling \$380.59; and

Section 2. \$56.88 be transferred from #2000-200-1009 Health Insurance (for Dental) and appropriated into #1000-500-1009 and \$.6.50 from #2000-200-1016 Life Insurance and appropriated into #1000-500-1016.

WHEREAS: The Van Buren County Sheriff's Office has two vehicles which are ready for replacement that the City of Clinton would like to purchase; and

- 4. Upon receiving the funds from this sale, the sum of \$14,000.00 shall be appropriated into line item 1000-0400-4005 Vehicles.
