WHEREAS: Van Buren County pays Workman's Compensation for Van Buren County's
Volunteer Fire Fighters; and

WHEREAS: the cost for Workman's Compensation was a little higher than anticipated for the
year 2025, putting the Personal Services category in the 'red'.

Section 1: \$67.23 be appropriated into #1000-502-1010 Workman's Compensation, for Van Buren

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN
ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE TO TRANSFER MONIES WITHIN THE ARKANSAS DEPARTMENT OF
EMERGENCY MANAGEMENT (OEM) BUDGET FOR PERSONAL SERVICES #1000-500 TO
CLEAN-UP PAYMENTS OF COMP. TIME FOR THE OEM AND TO MOVE MONEYS FROM THE
COUNTY ROAD BUDGET #2000-200 AND APPROPRIATE IN THE OEM BUDGET #1000-500
TO CORRECT PAYMENTS FOR THE OEM'S DENTAL AND LIFE INSURANCE FOR THE
MONTHS OF JULY AND AUGUST OF 2025.

WHEREAS: the OEM was approved by the County Judge to be paid for comp. time in February
of 2025. This has resulted in Personal Services being in the 'red' at the end of June 2025; and

WHEREAS: \$380.59 will need to be transferred from line #1000-500-9999 Transfer Out to
correct the overage, and

WHEREAS: the OEM position is paid from County General half of the year (Jan.-June) and
County Road the remaining half (July-Dec.). Dental insurance for the OEM was paid from
County General for July and August and Life insurance for July, and

WHEREAS: the monies will need to be transferred from County Road #2000-200 and
appropriated into the OEM County General Budget #1000-500 to correct these insurance
payments.

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF VAN BUREN COUNTY,
ARKANSAS THAT:

Section 1. \$329.47 be transferred from #1000-500-9999 Transfer Out to #1000-500-1001
Salaries: Full-Time, \$9.51 to #1000-500-1006 Social Security and \$41.61 to #1000-500-1008
Retirement, totaling \$380.59; and

Section 2. \$56.88 be transferred from #2000-200-1009 Health Insurance (for Dental) and
appropriated into #1000-500-1009 and \$.650 from #2000-200-1016 Life Insurance and
appropriated into #1000-500-1016.

AN EMERGENCY ORDINANCE TO AUTHORIZE THE SALE OF TWO
SHERIFF'S OFFICE VEHICLES TO THE CITY OF CLINTON, MO TO
APPROPRIATE THE FUNDS FROM THE SALE, TO DECLARE AN
EMERGENCY, AND FOR OTHER PURPOSES.

WHEREAS: The Van Buren County Sheriff's Office has two vehicles which are ready for replacement that the City of Clinton would like to purchase; and

WHEREAS: The City of Clinton has offered a price which is above the price received from the last vehicle trade; and

WHEREAS: Arkansas Code Annotated § 14-16-116 gives specific instructions for a transaction of this type.


NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS THAT:

1. The custodian of county property per ACA § 14-14-1102(3)(A), the Van Buren County Judge, is hereby authorized to sell the following ~~real~~ property to the City of Clinton:
 - a. 2016 Dodge Ram 1500 VIN 1C6RR7XT9GS250588
 - b. 2016 Dodge Ram 1500 VIN 1C6RR7XT0GS250589At a price of \$7,000.00 each for a total of \$14,000.00.
2. The property shall be sold "as-is".
3. Upon the close of the sale, the County Judge is hereby directed to remove said property from the county's fixed capital asset listing.
4. Upon receiving the funds from this sale, the sum of \$14,000.00 shall be appropriated into line item 1000-0400-4005 Vehicles.

Emergency Clause It is imperative for county operations to continue smoothly, efficiently and effectively, therefore this Ordinance being necessary for the protection and preservation of public health and safety, an emergency is hereby declared to exist and this Ordinance shall be in force and shall take effect upon passage and publication.



employee health insurance claims; and

WHEREAS: \$563,641.04 will be appropriated into line #1002-300-1009 Health Insurance to
cover the last six months of Health Insurance Claims for County Employees.


