**WHEREAS:** The Van Buren County Circuit Court Division 1 Judge has received a grant through the Arkansas Administrative Office of the Courts Security and Emergency Preparedness Program in the amount of \$576.28 to purchase a Portable Breathalyzer and a Hand-held Metal Detector; and

**Section 1:** Shirley school SRO position has been raised from \$17.69 to \$20.00 per hour.


**Section 2:** Southside/Bee Branch school SRO position has been raised from \$17.69 to \$19.00 per



remainder of 2025.



\$2,111.88 be transferred from #2000-200-1001 F/T Salaries to #1000-100-1001







AN EMERGENCY ORDINANCE TO ACKNOWLEDGE OZARK  
HEALTH, INC. AS THE CONTRACTED ADMINISTRATOR OF VAN  
BUREN COUNTY'S SENIOR CITIZENS PROGRAM, TO DECLARE AN  
EMERGENCY, AND FOR OTHER PURPOSES.

**WHEREAS:** Van Buren County Ordinance 2009-16 designates the distribution of the County's  
portion of the one-cent general sales and use tax; and

**WHEREAS:** There is a need to clarify a certain portion of Ordinance 2009-16 that distributes  
revenues to the "Senior Citizens Program"; and

**WHEREAS:** The Senior Citizens Program has been contracted to Ozark Health, Inc. under  
oversight by the White River Area Agency on Aging which has very specific rules and regulations  
in which Ozark Health, Inc. must follow regarding accounting, reporting, and operations; and

**WHEREAS:** The purpose of the Senior Citizens Program remains unchanged.


**NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF VAN BUREN  
COUNTY, ARKANSAS THAT:**

1. Ozark Health, Inc. is recognized as the contracted administrator of the county's Senior  
Citizens Program.
2. The "Senior Citizens Program," as designated in Ordinance 2009-16, shall be Ozark  
Health, Inc.
3. The Voluntary Tax Collected for the County Aging Program shall be remitted to Ozark  
Health, Inc.


**Emergency Clause** It is imperative for county operations to continue smoothly, efficiently and  
effectively, therefore this Ordinance being necessary for the protection and preservation of public  
health and safety, an emergency is hereby declared to exist and this Ordinance shall be in force  
and shall take effect upon passage and publication.
