BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN,  
STATE OF ARKANSAS, AN APPROPRIATION ORDINANCE TO BE ENTITLED:

AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL  
APPROPRIATION ORDINANCE #2016-52, THE ANNUAL OPERATING  
BUDGET FOR 2017, TO INCREASE THE PROJECTED REVENUE AND  
APPROPRIATE \$151,231.11 INTO THE CIRCUIT CLERK'S  
RECORDER'S COST FUND #3006-102 FROM THE CIRCUIT CLERK'S  
BUDGET #1000-102 AS SHOWN BELOW.

WHEREAS: The Circuit Clerk desires to operate 100% from recording fees; and

WHEREAS: There is a need to appropriate a portion of the Circuit Clerks Budget from County  
General to the Recorders Cost Fund.
