

**VAN BUREN COUNTY QUORUM COURT**

**ORDINANCE NO. 2019-03**

**BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:**

**AN ORDINANCE TO CREATE A NEW OFFICE BUDGET WITHIN COUNTY GENERAL FOR THE ELECTION COMMISSION #1000-109 AND TO TRANSFER MONIES FROM THE COUNTY CLERK'S BUDGET #1000-101 TO THE NEW ELECTION COMMISSION BUDGET;**

**WHEREAS:** During the 2019 Budget process, the Election Commission Budget was combined with the County Clerk's Office Budget; and

**WHEREAS:** These two budgets need to be separated; and

**WHEREAS:** The Deputy #2 position under the County Clerk's Office will be split between the County Clerk's Budget and the Election Commission Budget, totaling \$28,972.00, to cover both positions of Land Library Clerk and Election Coordinator.

**NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS THAT:**

**Section 1.** A new budget will be created for the Election Commission #1000-109.

**Section 2.** Monies will be transferred from the County Clerk's Budget #1000-101 to the new Election Commission Budget, as follows, with no additional monies added;
