BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, AN APPROPRIATION ORDINANCE TO BE ENTITLED:

AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE #2017-39, THE ANNUAL OPERATING BUDGET FOR 2018, TO INCREASE THE PROJECTED REVENUE AND APPROPRIATE \$45,000.00 INTO COUNTY GENERAL #1000-804-3119 FOR SOLID WASTE.

WHEREAS: The Solid Waste Fund #3009-700 is running short of funds in the 2018 budget to pay the bills already incurred and will need to be supplemented by County General; and

WHEREAS: The money will need to be appropriated into County General so that it may be transferred into the Solid Waste fund as needed.

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS THAT:

1. The original appropriation ordinance #2017-39 be amended, and
2. \$45,000.00 be appropriated into County General #1000-804-3119 to be transferred into the Solid Waste fund as needed.
